Course Description

MTU 15 and ILETSB are now able to provide agencies with the opportunity to have their officers attend one 40 hour class to cover all ILETSB required training mandates. This 40-hour Comprehensive Mandate Course will benefit the officers and the agencies alike by bringing multiple classes and instructors to one location. This class will cover Legal Updates, EMR, De-escalation, Firearms Training, Annual Firearms Qualification and more.

This course will provide students with a comprehensive learning environment that will allow them to not only meet their required individual training mandates, but the course will do so in a style that will require students to apply these specific training requirements to real-world scenarios prior to course completion. The course will provide a progression of learning that will address legal aspects of current law enforcement requirements, Emergency Medical Training / Practical Firearms Training, and Scenario-Based Training including De-Escalation Techniques, High-Risk Traffic Stops, and Use of Force. This progression process will provide students with the ability to not only learn the material, but it will allow students to build on prior lessons as the week progresses to ensure enhanced student retention of the statutory training mandates.

Prerequisite: Officers must take the following courses on the Online Learning Network prior to taking this 40-hour class. Certificates of completion must be emailed to mercedes@mtu15.com no later than 7 days prior to attending the class.

- -OSHA Hazardous Materials Awareness Refresher

Officers must bring the following gear:

Duty belt with handgun and three magazines; Patrol rifle and three magazines; 300 rounds pistol ammo; 300 rounds rifle ammo; Eye and ear protection

Course Objectives

- 1. Understand updated Illinois Vehicle Code statutes.
- 2. Understand updated Illinois Criminal Code statutes.
- 3. Understand the provisions of the 2021 SAFE T Act
- 4. Understand the provisions of the Firearms Restraining Order Act.
- 5. Understand statutes relevant to Orders of Protection and Stalking No Contact Orders.
- 6. Understand relevant sections of the Community Emergency Services and Support Act and Law Enforcement requirements under this act.
- 7. Understand current relevant state and federal case law.
- 8. Understand and demonstrate current Emergency Medical Response requirements and practices.
- 9. Understand the Importance of Tennessee v. Garner and Graham v. Connor as they relate to Law Enforcement Use of Force.
- 10. Understand current Illinois statutes governing Use of Force
- 11. Understand and demonstrate practical and safe firearms handling skills.
- 12. Understand and demonstrate proper barricade / cover use.
- 13. Understand and demonstrate proper use of different shooting positions.
- 14. Display at least minimum marksmanship proficiency during handgun, rifle, & shotgun qualifications shoots (if the student chooses to participate in this optional portion).
- 15. Understand and demonstrate De-Escalation practices and the importance of these skills in ensuring increased safety for both officers and the public.
- 16. Understand and demonstrate current High-Risk Traffic Stops practices emphasizing proper use of cover and verbalized commands to increase safety and efficiency in these situations.

This class will be taught by variety of MTU 15 training cadre that will bring their Law Enforcement experience and high training standards to the student officers.
