Course Description				
<p>Suicides are the leading cause of death in Illinois jails. Mental health issues are interfaced with this phenomenon. The course is designed to provide corrections officers, criminal justice, and law enforcement professionals in how to best address these most crucial corrections issues. The problem of suicide in jails is at what some experts call epidemic proportions in Illinois. Often inmates come to the jail with mental health issues that lead to and exacerbate their suicidal attempts. Litigation in jail suicide cases has cost the citizens of Illinois significant amounts of money. Experience tells us that almost all jail suicides can be prevented through a comprehensive program of recognition, assessment, and prevention. Programs that can be developed through information received in this training, begin at intake, and follows the inmate through his stay at the correctional facility. The program is designed to provide criminal justice officers with the skills and knowledge required to effectively respond and provide appropriate action. The skills addressed will include, but not be limited to legal, social, and criminal responses to jail suicides. This program has been designed with the purpose of addressing the issues related to suicide in the Illinois jail system. It meets all standards set forth by Illinois Administrative Code, title 20; Chapter 1 Subchapter f, section 701.90(h).</p>
