### Course Description

Law enforcement officers are usually the first responders to crisis events. This in-depth, 40-hour course is geared to the uniformed patrol law enforcement officer who will be required to respond to crisis calls involving people with behavioral disabilities. It will provide police officers with education about mental illness and other behavioral disabilities and skills and tools for effective and safe interaction.
