Course Description

This course will introduce officers to basic SWAT tactics. Officers will be instructed on SWAT planning and response to critical incidents, the application of SWAT in high-risk warrant execution and barricaded subject and hostage incidents. Officers will be instructed on dynamic and stealth entries, officer deployment, and team movements. The class will also include a review of legal issues of Illinois Compiled Statute regarding Peace Officers Use of Force in Making Arrest. The practical exercise portion of this training will involve use of force scenario-based training exercises.
