### Course Description

It is vital that all law enforcement officers develop a good understanding the recognition, collection, preservation, use, and disposal of evidence. The Illinois Legislature has created its own set of rules concerning how evidence is dealt with in criminal justice cases. Additionally, the Courts have adopted its own Rules of Evidence. Finally, each agency has its own policies and procedures concerning how their officers are expected to deal with evidence of criminal activity discovered as officers perform their duties.

This presentation will cover all aspects of this subject. It will identify the statutory provides and court rules concerning the collection and use of evidence in Illinois. The most recent criminal justice cases will be identified and analyzed to illustrate the appropriate methods of recognizing and handling evidence of criminal activity and to illustrate some of the problem areas Illinois Law Enforcement Officials face when dealing with such evidence. The ultimate goal of the Evidence Law Analysis and Update is to “de-mystify” the use of criminal justice evidence and assist Illinois Law Enforcement Officers in performing their duties.
