Course Description

Beginning January of 2021, any Illinois law enforcement officer serving as a School Resource Officer (SRO), pursuant to an agreement between a school district and a law enforcement agency, must be certified as having completed the “necessary” course of instruction. This class satisfies all these requirements and will provide officers with an overview of the School Resource Officer position, the duties to be performed, and the differences in approach and analysis required in the school setting compared to general patrol.

The final day of this 5-day class will be devoted to the necessary Active Threat Response training utilizing force-on-force scenarios. This will require participants to provide protective equipment including a thick long-sleeve shirt or jacket, gloves, and safety glasses. Officers should also bring all duty belt gear, excluding any and all weapons (firearms, TASERS, OC Spray, knives, etc.).

As an expert, she has sat on the State's Attorney Task Force for the Mass Molestation of Children and The Cook County Child Death Review Team. She has developed a curriculum that meets State requirements for the certification of juvenile police officers. She provides training for the Cook County Adult

Probation Department, Illinois Crisis Intervention Team and Homeland Security, as well as MTUs across the state of Illinois.
